July 8 = 7:30 Assembly, 8:00 Shoot will start {28 Hunter (black face with white X-ring)}

- This is a pre-registration shoot. You must register by Friday, July 6, 2007 at 8:00 PM
- All Divisions will be flighted if there is enough shooter in that style. You must shoot both days to be eligible for awards.
- You must be a member of the WFAA/NFAA. You can join the WFAA/NFAA at the tournament.
